If you have a joint membership (memberships in more than one name), either member on the account can run for the board of trustees. If only your spouse's name is on the account, your spouse is the only one eligible to run for the board of trustees. A joint membership is only entitled to one vote at any meeting of the cooperative.

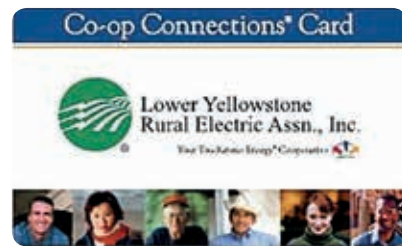
There are no forms to complete and it costs you nothing! Simply provide your card to the pharmacist

Billing cycle changes

Lower Yellowstone Rural Electric Cooperative (LYREC) will be changing the billing cycle in 2016. The goal of this change is to have the current bill reflect the entire previous month's usage. For example, the bill that comes out in March will be for the month of February. To get this accomplished, LYREC has been adding a couple extra days to the bill each month since the November billing. The benefit of adding a couple days on each month's bill is so there is not such a significant jump in days billed on the March billing.

Beginning in March, the bills will be processed around the 5th of the month; this may vary depending on the weekends. The payments will be

due on the 20th of the month. If you have ACH or automatic payments, the funds will be debited from your account on the 15th of the month, rather than the fourth or the fifth.

LYREC offers several payment options for your convenience. If you would like to sign up for ACH, LYREC will need you to sign a form and provide a voided check. You will still get your bill in the mail every month, but your payment will automatically be debited from your checking account on the 15th of each month. This is fast, easy and secure!

Another option is e-bill. To access e-bill, log onto www.lyrec.com, and click on the "Online Bill Pay" tab. To sign up for e-bill, you will need your account number and an email address.

E-bill will send an email as soon as your bill is available. At that time, you can either pay your bill online or you can call the LYREC office and make a payment over the phone using your credit or debit card or your checking account. You will be able to view your current/past bills and usage information through e-bill.

LYREC also has two drop boxes for your convenience. One drop box is located at the LYREC office and the other is located on Second Ave. N.W. across the road from Reese and Ray's IGA.

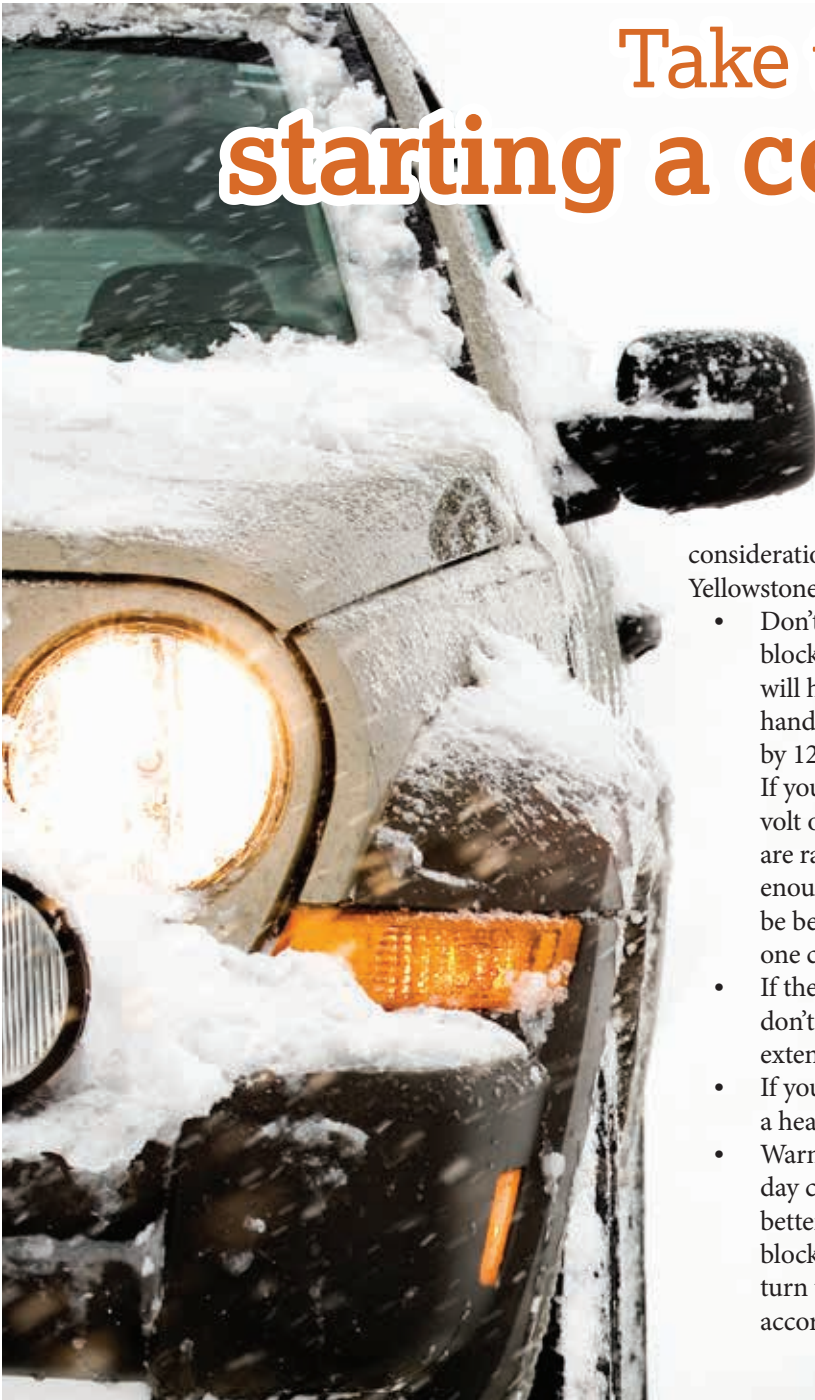
Statement of nondiscrimination

Take the brrrr out of starting a cold vehicle

Will your vehicle start Monday morning when it's 30 degrees below zero? When your vehicle doesn't start due to frigid temperatures, it can be frustrating. That's why most area residents use an engine block heater on their vehicles. Engine block heaters keep your vehicle's motor warm, allowing an easy start on those cold mornings. But there are some considerations when using an engine block heater. Lower Yellowstone Rural Electric Cooperative offers these tips:

- Don't overload a circuit by plugging your engine block heater into just any outlet. A simple formula will help you decide how many watts one circuit can handle. Divide the wattage of the engine block heater by 120 volts to find out how many amps will be used. If you plug a 640-watt engine block heater into a 120-volt outlet, you are using 5.33 amps. Circuit breakers are rated in amps, so make sure the circuit has enough amps to carry the additional load. It might be best to use an exterior outlet that is protected by one circuit breaker and has ample capacity.
- If the engine block heater has a three-prong plug, don't alter it. Always leave the plug intact and attach extension cords correctly.
- If you use an extension cord outdoors, make sure it is a heavy-duty extension cord rated for outdoor use.
- Warming your engine all night and sometimes all day can use a significant amount of electricity. For better energy efficiency, purchase a timer for your block heater. A timer allows you to automatically turn the engine heater to on-and-off intervals according to your specifications. ■

Assistance is available

If you or someone you know needs help this heating season, funds are available. If you reside in Montana, you can contact Energy Share at 800-227-0703. If you reside in North Dakota, contact Community Action at 701-572-8191. Montana residents may pick up an application at Lower Yellowstone Rural Electric Cooperative (LYREC) for the Low Income Home Energy Assistance Program (LIHEAP).

Once you submit your application, it can take up to two months before receiving assistance. If you are finding yourself in a financial bind, please pick up an application today. Below are the income eligibility criteria for 2015-2016.


Number in household	Annual Income
1.....	\$23,540
2.....	\$31,860
3.....	\$40,180
4.....	\$48,500
5.....	\$56,820
6.....	\$65,140

For your application to be processed, you will need a copy of your most recent fuel bill, 12 months of income verification for all persons in the household (such as wages, Social Security/SSI, veterans' benefits, child support and unemployment), proof of current resources (bank statements) and a photo ID for all household members 18 years and older or a birth certificate for children 17 and under.

Failure to provide all requested information and verification will delay the eligibility determination and may result in application denial.

If you turn in your application in February 2016; provide verification of income for February 2015 through January 2016.

If you do not fall within these guidelines, but you are still in need of financial assistance, please call LYREC at 406-488-1602 for other referrals. ■


