### Submit a photo to enter to win a scholarship!

Who can enter: The applicant's parent or legal guardian must be a current LYREC member, and the applicant must be enrolled or planning to enroll in a full-time college, university or vocational school in the fall of 2025. Applicants may receive a maximum of two annual meeting scholarships.

**What:** Original photos capturing the serenity and beauty of LYREC's service territory.

#### What to submit:

- The applicant must provide a tagline for the photo.
- The applicant must submit a separate photo of themselves.
- A completed and signed annual meeting photo contest application.

**How to submit:** Email the photos and completed registration form to scholarships@lyrec.coop. Photos must be submitted as digital images with a minimum size of 3 MB. They must be at least 300 DPI at actual size and saved as .jpg, .png or .tiff files.

**Deadline:** May 27

The scholarship recipients will be drawn at random and announced at the June 4 annual meeting. However, if any required information is missing or the photos do not meet the size requirements, the applicant will be omitted from the scholarship pool. Applicants' attendance at the annual meeting is recommended.

# **Facility charge**

If you've ever examined your bill closely, you may have noticed a separate line item for a facility charge. Lower Yellowstone Rural Electric Cooperative (LYREC) serves a wide range of members, including some who use electricity year-round and others who only need it for part of the year. Regardless of usage, the cost of delivering power remains the same.

The facility charge is a fixed monthly fee that helps cover the essential operating costs of the utility, ensuring reliable service. Similar to monthly charges for phone or TV services, this fee supports the infrastructure, equipment and personnel needed to keep electricity available at all times.

So, whether you're heating your home, operating a well pump or irrigating your fields, power is always ready at the flip of a switch, thanks to the ongoing investment of your cooperative.

### Capital credits returned

In December 2024, Lower Yellowstone Rural Electric Cooperative (LYREC) returned over \$2 million in retired capital credits to its members. Capital credits come from margins, or money remaining at the end of the year after all operating expenses have been paid. The margins are allocated to each member's capital credit account based on the member's electricity usage. The allocated margins are retained and used by
